TERMS OF USE AGREEMENT

EFFECTIVE DATE: FEBRUARY 15, 2021

1. GENERAL

This Terms of Use Agreement (referred to as “Terms of Use”, “ToU”, “Agreement” or “Terms”) sets the terms and conditions for use for the following software services:

- A. ILGON Wallet at <https://ilgonwallet.com>
- B. ILGON Mobile Wallet iOS application
- C. ILGON Mobile Wallet Android application
- D. ILGON Block Explorer at <https://ilgonexplorer.com>

(collectively referred to as “ILGON Technology Services” or “Services”)

These Terms of Use form a legally binding agreement between **the User of ILGON Technology Services** whether personally or on behalf of an entity (referred to as “You”, “Your”, or “User”) and **Technokrats Kft.**, company reg. no.: 01-09-908333, reg. office: 1054 Budapest, Szabadság tér 7. 2. em. 1. (referred to as “ILGON Technologies”, “We”, “Us”, “Our”, “Service Provider” or “Provider”) concerning the access and use of ILGON Technology Services.

1.1. Acceptance of Terms

By accessing or using any of ILGON Technology Services You acknowledge that You have read, understood, and agreed to be bound by this Agreement.

Furthermore, You acknowledge that these Terms of Use are supported by reasonable and valuable consideration, the receipt and adequacy of which are hereby acknowledged. Without limiting the generality of the foregoing, you acknowledge that such consideration includes your use of the Services and receipt of data and information available through the Services.

1.2. Changes and Revisions

You acknowledge that ILGON Technologies reserves the right to revise and update these Terms of Use from time to time at its sole discretion.

The Service Provider may attempt to notify You when major changes are made to this Agreement, however, You should periodically review the most up-to-date version of the Agreement.

The date for the last modification of the Agreement is showcased by the “Effective Date” of the Agreement and all changes are effective immediately.

By continuing to access and/or use ILGON Technology Services after the “Effective Date” of a revised Agreement, you agree to be bound by the revised Agreement.

IF YOU DO NOT AGREE TO THIS AGREEMENT OR ANY MODIFICATIONS TO THIS AGREEMENT, YOUR SOLE REMEDY SHALL BE TO DISCONTINUE YOUR USE OF ILGON TECHNOLOGY SERVICES.

1.3. Transfer of Rights

The Service Provider may transfer the rights and obligations under this Agreement to another organization, and will always notify you in writing if this happens, but this will not affect Your rights or obligations under this Agreement.

You agree that the Provider may assign any of its rights and/or transfer, sub-contract, or delegate any of its obligations under these Terms of Use.

YOUR AGREEMENT TO THESE TERMS IS PERSONAL TO YOU AND YOU MAY NOT TRANSFER OR ASSIGN IT TO ANY THIRD PARTY.

1.4. Severability

If any part of this Agreement is invalid, void, or for any reason unenforceable, that term will be deemed severable and limited or eliminated to the minimum extent necessary.

EACH OF THE PARAGRAPHS OF THESE TERMS OPERATES SEPARATELY. IF ANY COURT OR RELEVANT AUTHORITY DECIDES THAT ANY OF THEM ARE UNLAWFUL, THE REMAINING PARAGRAPHS WILL REMAIN IN FULL FORCE AND EFFECT.

1.5. Termination of the Agreement

In the event of termination concerning your license to use ILGON Technology Services, your obligations under this Agreement will still continue.

2. ELIGIBILITY

BY USING ILGON TECHNOLOGY SERVICES, YOU REPRESENT AND WARRANT THAT YOU MEET ALL ELIGIBILITY REQUIREMENTS THAT ARE OUTLINED IN THESE TERMS OF USE.

2.1. Local Compliance

ILGON Technology Services can be accessed via the internet and thereby the Services may be accessible globally. Accessing and using ILGON Technology Services may not be legal by certain individuals or in certain countries.

You hereby agree to comply with all local rules and laws relating to the use of ILGON Technology Services, cryptocurrency ownership or transfer, and blockchain interaction.

YOU CAN USE ILGON TECHNOLOGY SERVICES ONLY IF PERMITTED UNDER THE LAWS OF YOUR JURISDICTION. MAKE SURE THAT THIS AGREEMENT IS IN COMPLIANCE WITH ALL LAWS, RULES, AND REGULATIONS THAT APPLY TO YOU.

2.4. Changes to the Eligibility criteria

ILGON Technologies reserves the right to change the eligibility criteria at any time and without prior notice.

3. PRIVACY

3.2. Data Collection

3.2.1. Personal information

ILGON Technology Services does not require you to provide any personal information. The backend of the Services is designed to protect privacy, and it does not store any privacy-sensitive information.

3.2.2. Analytics

ILGON Technology Services does not collect any analytics data and it does not track user behavior.

3.2.3. Crash Report

In case of an error or crash occurs in any of the Services, an automated error report is sent directly to our servers without going through a third party.

3.3. Blockchain Data

Due to the inherent transparency of distributed ledger technologies, including the ILGON Blockchain, transactions that individuals broadcast via the Services may be publicly accessible. This includes, but is not limited to a) your public sending address; b) the public address of the receiver; c) the amount sent or received; d) any other data a user has chosen to include in a given transaction.

Transactions and addresses may reveal information about the user's identity and information can potentially be correlated now or in the future by any party who chooses to do so, including law enforcement.

YOU UNDERSTAND AND ACKNOWLEDGE THAT INFORMATION STORED ON A BLOCKCHAIN MAY BE PUBLIC, IMMUTABLE, AND DIFFICULT OR EVEN IMPOSSIBLE TO REMOVE OR DELETE.

4. RESTRICTIONS

5.1. Service explanations

5.1.1. Wallet

When You access certain features of the Services, You will be able to generate a wallet and/or access a wallet to perform a variety of transactions. You will receive a key and set up a

password, but You do not and will not create an account with ILGON Technologies. You also will not give us any of your assets, and Your tokens and coins are not on ILGON Wallet. All assets are on the blockchain itself, and we do not control them.

5.1.2. Fees

ILGON Technologies does not charge any fees for installation or use of the Services. ILGON blockchain transactions need to include a transaction-fee which gets collected by the ILGON network - ILGON Technologies have no direct influence on transaction fees.

5.1.3. Transacting on the blockchain

Digital Asset transactions in order to be completed, all proposed transactions must be confirmed and recorded in the ILGON blockchain. The ILGON blockchain is a peer-to-peer network, therefore ILGON Technologies is unable to ensure that any transaction details that You submit via the Services will be confirmed and processed.

By using the Services, you acknowledge and agree that the transaction details you submit may not be completed.

ILGON TECHNOLOGIES DOES NOT STORE, SEND, OR RECEIVE THE USER'S DIGITAL ASSETS. ANY TRANSFER THAT OCCURS IN ANY DIGITAL ASSET OCCURS ON THE ILGON-BASED BLOCKCHAIN.

YOU REPRESENT AND WARRANT THAT ANY INFORMATION YOU PROVIDE VIA THE SERVICES IS ACCURATE AND COMPLETE. YOU ACCEPT AND ACKNOWLEDGE THAT WE ARE NOT RESPONSIBLE FOR ANY ERRORS OR OMISSIONS THAT YOU MAKE IN CONNECTION WITH ANY DIGITAL ASSET TRANSACTION INITIATED VIA THE SERVICES. WE STRONGLY ENCOURAGE YOU TO REVIEW YOUR TRANSACTION DETAILS CAREFULLY BEFORE ATTEMPTING TO TRANSFER A DIGITAL ASSET.

5.1.4. Backup

ILGON Technologies does not collect or hold your keys or information, and ILGON Technologies cannot access wallets, accounts; recover keys, passwords, or other information; reset passwords; or reverse transactions.

ILGON Technologies cannot assist with password retrieval. Services store your Wallet address but does not receive or store your Wallet password, encrypted private key, unencrypted private key, or mnemonic (backup) phrase associated with your Wallet. We cannot, therefore, assist you with Wallet password retrieval. We cannot generate a new password for your Wallet if you fail to remember your original password. If you have not safely stored a backup of any Wallet address and private key pairs maintained in your Wallet, you accept and acknowledge that any Digital Asset you have associated with such a Wallet address will become inaccessible if you do not have your Wallet password.

YOU ARE SOLELY RESPONSIBLE FOR YOUR USE OF THE SERVICES, INCLUDING WITHOUT LIMITATION FOR STORING, BACKING-UP, AND MAINTAINING THE CONFIDENTIALITY OF YOUR KEYS, PASSWORDS, AND INFORMATION, AND FOR THE SECURITY OF ANY TRANSACTIONS YOU PERFORM USING THE SERVICES.

5.2. Availability

5.2.1. Geo availability

The Service Provider makes no claims that ILGON Technology Services or any of its content is accessible or appropriate outside of the European Union.

IF YOU ACCESS THE SERVICES FROM OUTSIDE THE EUROPEAN UNION, YOU DO SO ON YOUR OWN INITIATIVE AND YOU ARE RESPONSIBLE FOR COMPLIANCE WITH LOCAL LAWS.

5.2.2. Continuance of Service

The Provider may, in its sole discretion and without cost to you, with or without prior notice, and at any time, modify or discontinue, temporarily or permanently, any portion of the Services. You are solely responsible for storing outside of the Services a backup of any Wallet address and private key pair that you maintain in your Wallet.

Maintaining an external backup of any Wallet address and private key pairs associated with your Wallet will allow you to access the ILGON Network upon which your Wallet is secured. Such a backup will allow You to fully restore Your Wallet at any time without cost or loss of the Digital Assets.

ILGON TECHNOLOGIES SHALL NOT BE HELD RESPONSIBLE OR LIABLE FOR ANY LOSS OF DIGITAL ASSETS IN THE EVENT THAT WE DISCONTINUE OR DEPRECIATE THE SERVICES.

6. LIMITATIONS OF LIABILITIES, WARRANTIES

7.2. Indemnification

The terms of the Terms of Use in the English language shall prevail over any terms of any translations hereof in the event any dispute arises regarding any conflicting terms.

YOU AND ILGON TECHNOLOGIES AGREE THAT ANY CAUSE OF ACTION ARISING OUT OF OR RELATED TO THE SERVICES MUST COMMENCE WITHIN ONE (1) YEAR AFTER THE CAUSE OF ACTION ACCRUES. OTHERWISE, SUCH CAUSE OF ACTION IS PERMANENTLY BARRED TO THE EXTENT PERMITTED BY LAW.

Source code originated from open-source projects are separately licensed, and the license in this agreement does not cover the open-source software that is built into ILGON Technology Services.

8.2. Licensing

ILGON Technologies grants you a non-transferable, non-exclusive, worldwide, royalty-free non-transferable, non-exclusive, worldwide, royalty-free license for access and use.

This license does not grant you any rights to use ILGON's name, logo, or trademarks, product and service names, designs and slogans. You must not use such marks without the prior written permission of ILGON Technologies.

IN NO EVENT SHALL THE AUTHORS OR COPYRIGHT HOLDERS BE LIABLE FOR ANY CLAIM, DAMAGES OR OTHER LIABILITY, WHETHER IN AN ACTION OF CONTRACT, TORT OR OTHERWISE, ARISING FROM, OUT OF OR IN CONNECTION WITH THE SOFTWARE OR THE USE OR OTHER DEALINGS IN THE SOFTWARE.

9. MISCELLANEOUS

9.1. No waiver
